SUBJECT: CLARIFICATION REGARDING ADVERTISED POSTS IN THE CATEGORIES OF ASSISTANT DIRECTOR, ASSISTANT, AND ASSISTANT ACCOUNT OFFICER

The Sindh Higher Education Commission hereby informs all eligible candidates who have applied for multiple positions of Assistant Director that a single written test shall be conducted for all advertised posts of Assistant Director.

02. Accordingly, one test slip has been issued to such eligible candidates from amongst the posts he/she has been found eligible. Therefore, such candidates are required to submit a separate Pay Order / Demand Draft of **Rs. 2,000/- (Rupees Two Thousand Only)** for each additional position, drawn in favour of "Sindh Higher Education Commission" bearing NTN No. 9033469-7.

03. For ease of reference, candidates who have applied for multiple positions of Assistant Director may locate their allocated Test ID in **Annexure-I**, which links candidate details with their respective Test IDs. This arrangement ensures that appearance in a single test shall suffice for consideration against all applied positions of Assistant Director, subject to submission of the prescribed Demand Drafts.

04. Similarly, a single written test shall be conducted for candidates who have applied for the posts of Assistant and Assistant Accounts Officer. Such eligible candidates are required to submit separate Pay Order / Demand Draft of **Rs. 1,000/- (Rupees One Thousand Only)** for each post, drawn in favour of "Sindh Higher Education Commission" bearing NTN No. 9033469-7. The list of such candidates is provided at **Annexure-II**; they have been allotted a single Test ID and will be considered for both positions upon submission of the required Demand Drafts.

05. This general clarification applies specifically to those candidates who have submitted applications for more than one of the following positions: Assistant Directors, Assistant, and Assistant Accounts Officer. It aims to guide such candidates regarding the conduct of a single written test, allocation of a unified Test ID, and the applicable fee requirements for each additional post.

06. The tests will be conducted as per the following schedule:
